Shiv Nadar Foundation has instituted **GRD Centenary Scholarship to 1st year BE/BTech students** admitted during 2023-2024. **Guide Lines for the Award of GRD Centenary Scholarship instituted by
Shiv Nadar Foundation**

1) Eligibility:

First year BE/BTech Regular and Sandwich students of PSG College of Technology admitted through Anna University single window counselling.

2) Economical Status:

Parental income should be less than Rs 2.5 Lakhs per annum

3) Academic performance:

For continuation of the scholarship beyond first year, students must maintain good academic record with a cumulative grade point average of not less than 6.5 at the time of renewal of the scholarship. However students with not more than two current arrears may be considered if the reason for failure is valid and acceptable by the committee. Students not satisfying the above requirements, will not be eligible for the scholarship.

4) +2 Performance:

The Engineering cut off mark of the students must be more than 180/200 (90 %)

5) Scholarship Amount:

The scholarship amount is calculated based on the actual fee payable by the student including hostel expenditure subjected to a maximum limit of Rs 1.1 Lakhs per year. In addition if the student receives any other government scholarship such as BC Scholarship or SC/ST Scholarship, the total amount will be reduced accordingly.

6) Disbursement of Scholarship

For senior class students selected for the Scholarship, the amount will be disbursed during the end of June before the last date of payment of fees. For first year students the scholarship amount will be disbursed during the end of Oct.

7) Discontinuation of Scholarship

The scholarship given to the students in the first year will continue for entire 4 year period of their studies. Sandwich students receive scholarship only for the first 4 years of their study. If any student is found to be involved and is punished for any indiscipline in the campus, the scholarship will be terminated.

8) Number of scholarships

Two boys and two girls from among first year students will be eligible to receive the scholarship every year. However if the total amount given to the students is less than Rs 4.4 Lakhs, one more student may be considered for the scholarship.

- ii. The annual income of parents must be less than Rs2.5 Lakhs per annum.
- iii. The scholarship amount would cover the student's entire tuition fee, hostel fee and food expenses up to a maximum of Rs 1.1 Lakh per year.
